Indiana –	Massachusetts –
Consumer privacy. Requires businesses to disclose certain information to consumers. Outlines different requests a consumer may make with businesses regarding the consumer's personal information. Assigns enforcement of consumer privacy law to the Indiana division of consumer protection. Provides certain business exceptions (<u>HB1261</u>)	Massachusetts Information Privacy Act (SB2867)

Establishing the Workgroup on Online Consumer Personal Information Privacy to review current practices of business entities relating to the collection, use, storage, disclosure, analysis, deletion, and modification of online personal information of consumers in the State; and requiring the Workgroup to report its findings and recommendations, including any recommended legislation, to the Governor and certain committees of the General (<u>SB11</u>)	Consumer Privacy Act (HB5989)
